Funding News - COVID-19 Related

COVID-19: CEBA (Canada Business Emergency Account) offers interest-free loans of up to \$40,000 to small businesses and not-for-profits. The program will now be available to businesses with sole proprietors, those that rely on contractors, and, family-owned businesses that pay employees through dividends rather than payroll.

WES & COVID-19: \$15M in new capital will go to current recipients of the Women's Entrepreneurship Strategy (WES) Ecosystems Fund to assist women run businesses navigate COVID-19 issues.

Nanostics: A U of A company is developing a simple blood test to predict the severity of COVID-19 using diagnostic technology to help health professionals intervene more quickly and efficiently with patients who are likely to need hospital care.

After a successful pilot test, SDTC has announced the expansion of its pilot test of a new Seed Fund. The Seed Fund partners with accelerators across Canada to fund early stage start-up companies pursuing potentially breakthrough environmental technologies. The Seed Fund will extend SDTC's reach along the length of the technology development pipeline.

The European Commission, has announced the "world's greenest recovery package". The EU's goal is to transform its existing plan to reach net-zero emissions by 2050 into "a coronavirus economic rescue plan that'll rapidly drive private investment and create jobs across the continent". It's the EU's plan for making the economy sustainable.
